HOSTING TERMS

Hosting fees are \$131.88 for the year for Non PMRNC subscribers and are billed **annually**, one month prior to the next billing period and payable within 15 days of the invoice. An additional discount is available if you pay your invoice on time and online. Hosting for Subscribers is just \$119.88 annually. Hosting invoices will be sent out via email approximately 20-30 days before the expiration of your hosting period. Invoices are payable within 15 days of the date on the invoice. Accounts not paid by the due date are subject to suspension. If your hosting account is suspended, there is an additional \$99 Fee to backup, restore, and retrieve your site files. Backups are kept ONLY for 90 days from the date of the original invoice.
